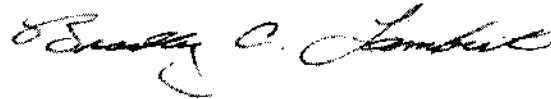
CONCLUSION:

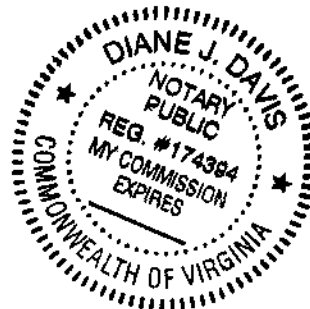

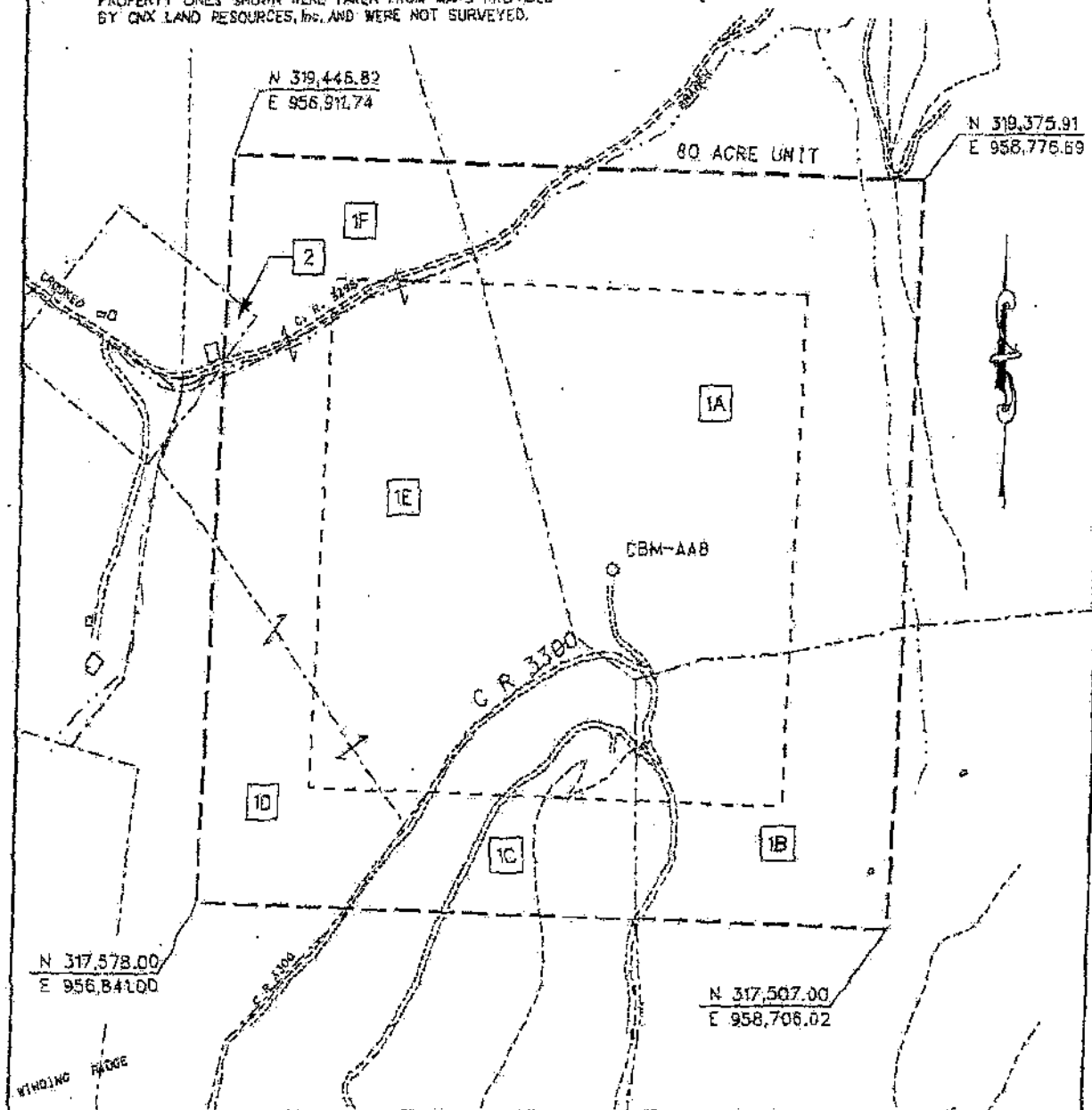
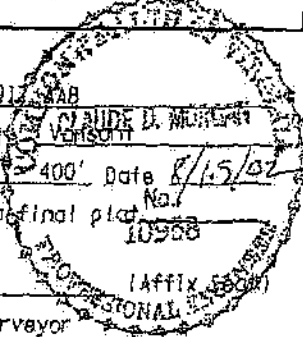
