**NOTICE:**

Applicant has certified and represented to the Board that:

Mary Katharine Arnold, Inez Kimbrell, Wanda Griffith, Sherman Baldwin, Allene Smith, Nancy Komp, Sandra Cranmer, Donna Foote, Pamela Case, Rufus Baldwin, David Baldwin, Tammy Muir, Sharon Baldwin, Eddie Baldwin, Kathy Whitt, and Lisa Shaver are the gas claimants in Tracts portion of Tr. 2. As such Mary Katharine Arnold, Inez Kimbrell, Wanda Griffith, Sherman Baldwin, Allene Smith, Nancy Komp, Sandra Cranmer, Donna Foote, Pamela Case, Rufus Baldwin, David Baldwin, Tammy Muir, Sharon Baldwin, Eddie Baldwin, Kathy Whitt, and Lisa Shaver are entitled to 100% of the CBM royalties now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- b. That CNX Gas Company LLC has previously given the notice(s) required by § 45.1-361.22:2.A to all conflicting coal claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- c. That when the Board granted Petitioner's Miscellaneous Petition in VGOB 97-0218-0563-06, it dismissed the coal claimant(s) Yukon Pochontas, et al as a Respondent to these proceedings. Accordingly, Yukon Pochontas, et al was not provided further notice under § 45.1-361.19 and 22 of the hearing set on this Petition.
- d. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- e. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement(s) is to be calculated and paid by the escrow agent.
- f. That Va. Code Ann. § 45.1-361.22:2.A. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimants Mary Katharine Arnold, Inez Kimbrell, Wanda Griffith, Sherman Baldwin, Allene Smith, Nancy Komp, Sandra Cranmer, Donna Foote, Pamela Case, Rufus Baldwin, David Baldwin, Tammy Muir, Sharon Baldwin, Eddie Baldwin, Kathy Whitt, and Lisa Shaver and not escrow same. 1. The Escrow Agent is ordered, to within ten (10) days of receipt of this executed order, disburse funds for the unit and applicants detailed in Table 1.
2. The Escrow Agent is ordered to continue the Escrow Account for the Subject Drilling unit based on the attached Revised Exhibit E which replaces all prior Exhibit E's recorded for the Subject Drilling Unit.

**CONCLUSION:**

Therefore, the requested relief and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.

**APPEALS:**

Appeals of this Order are governed by the provisions of the Code of Virginia § 45.1-361.9 which provides that any order or decision of the Board may be appealed to the appropriate circuit court and that whenever a coal owner, coal operator, gas owner, gas operator, or operator of a gas storage field certificated by the State Corporation Commission is a party in such action, the court shall hear such appeal de novo.




