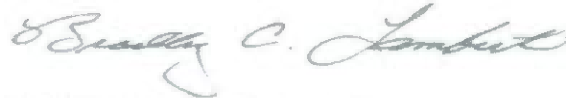
CONCLUSION:

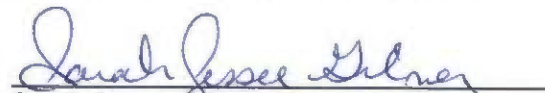

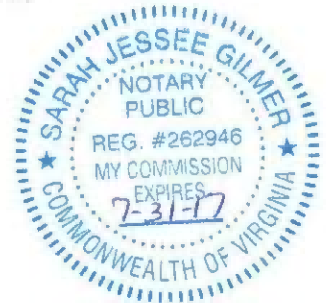

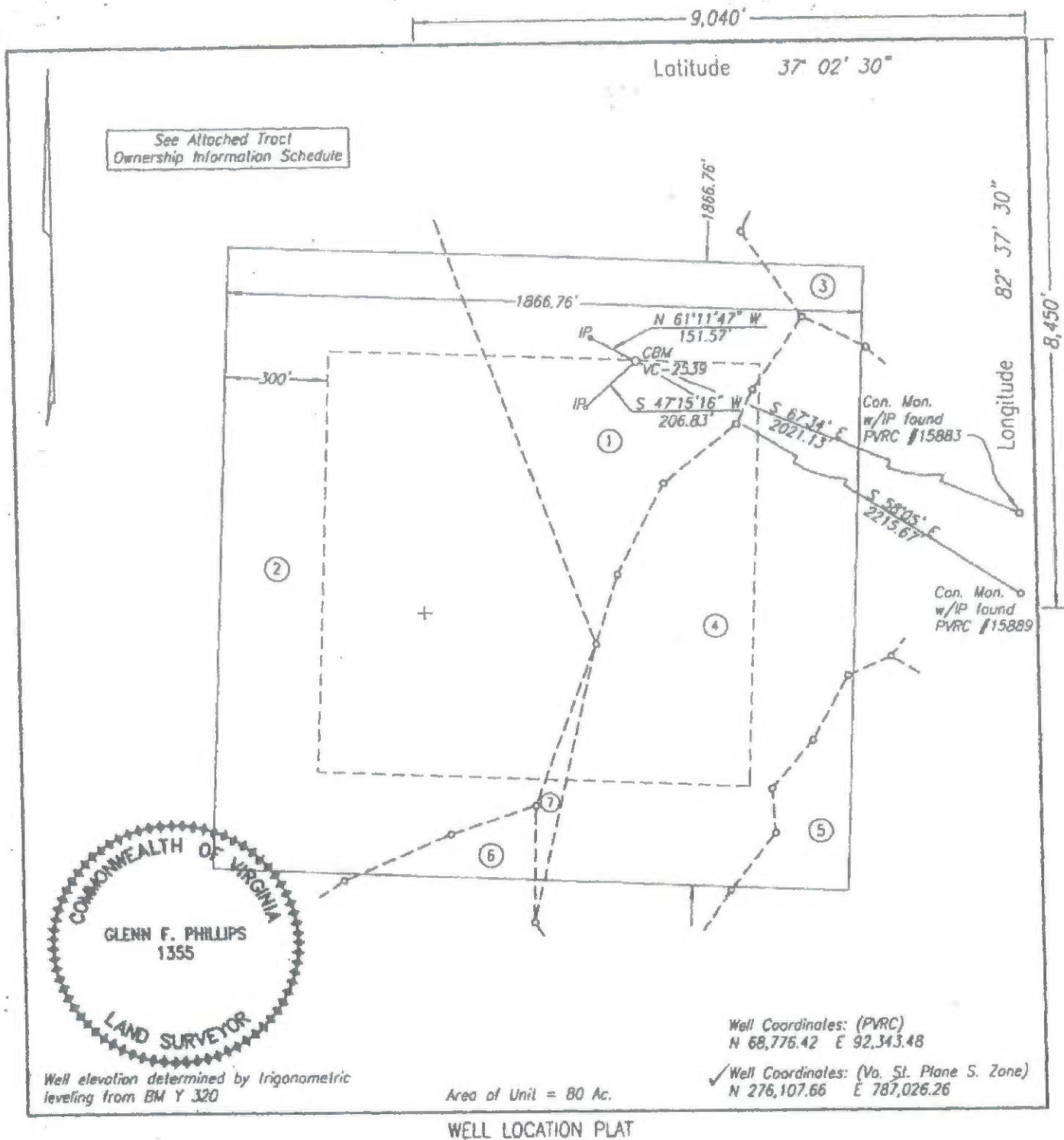
