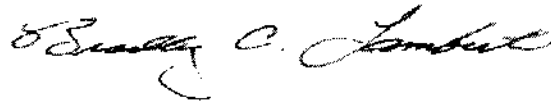
**CONCLUSION:**

**APPEALS:**

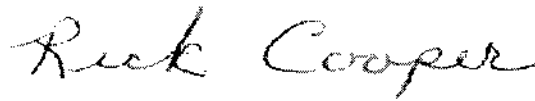

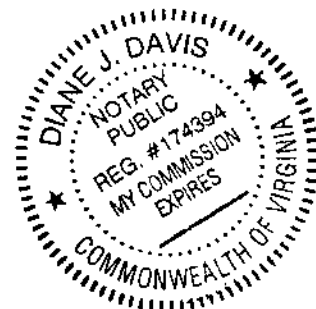

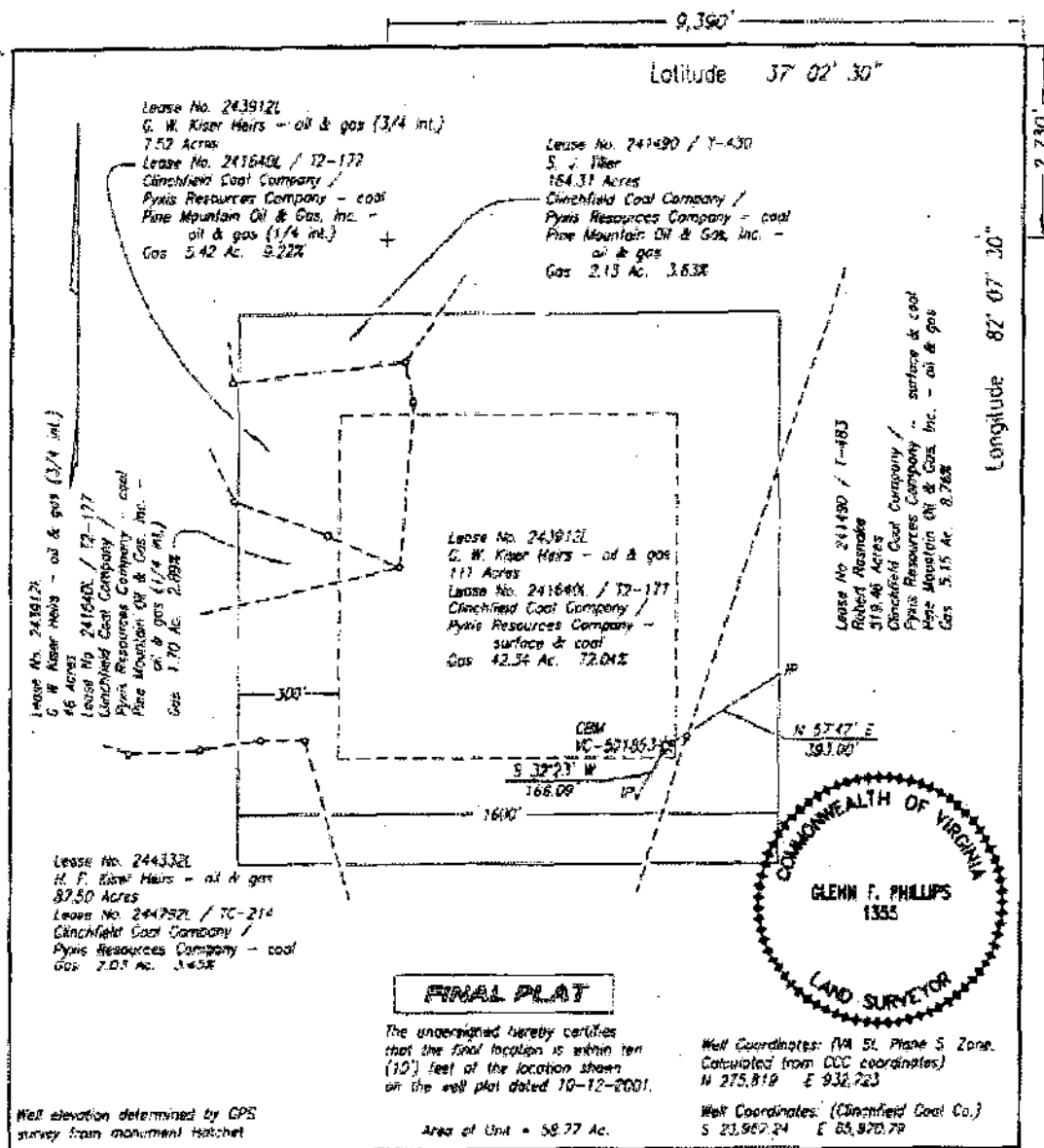
