- a. James H. Boyd, Charles M. Boyd, David G. Boyd, Shelia R. Conrad, Terry Boyd, and Shelia Perkins are the gas claimants in a portion of Tr. 1A, and portion of Tr. 1F. As such James H. Boyd, Charles M. Boyd, David G. Boyd, Shelia R. Conrad, Terry Boyd, and Shelia Perkins are entitled to 100% of the CBM royalties attributable to their gas claims that are now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- b. That CNX Gas Company LLC has previously given the notice(s) required by § 45.1-361.22:2.A to all conflicting coal claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- c. That when the Board granted Petitioner's Miscellaneous Petition in VGOB 00-1017-0830-04, it dismissed the coal claimant(s) Hugh MacRae Land Trust (Torch Oil & Gas), Chisos, LTD, and Rockport Oil & Gas as a Respondent to these proceedings. Accordingly,) Hugh MacRae Land Trust (Torch Oil & Gas), Chisos, LTD, and Rockport Oil & Gas was not provided further notice under § 45.1-361.19 and 22 of the hearing set on this Petition.
- d. That a detailed accounting in accordance with the applicable provisions of § 45.1-361.22 is submitted herewith and identified as Exhibit J.
- e. That an Exhibit identified as Table 1 is annexed hereto, and it specifies how the disbursement(s) is to be calculated and paid by the escrow agent.
- f. That Va. Code Ann. § 45.1-361.22:2.A. further provides that the Operator shall pay such royalties as may hereafter be payable directly to the gas claimant James H. Boyd, Charles M. Boyd, David G. Boyd, Shelia R. Conrad, Terry Boyd, and Shelia Perkins and shall not escrow same. See Exhibit EE annexed hereto.

1. The Escrow Agent is ordered, to within ten (10) days of receipt of this executed order, disburse funds for the unit and applicants detailed in Table 1.
2. The Escrow Agent is ordered to continue the Escrow Account for the Subject Drilling unit based on the attached Revised Exhibit E which replaces all prior Exhibit E's recorded for the Subject Drilling Unit.


CONCLUSION:





