The Unit Operator gave notice to the Applicants that the Board would consider its disbursement petition at the April 19, 2016 hearing and was continued to May 10, 2016 where the Board considered whether to:

- (2) Delete the requirement that the Unit Operator place future royalties attributable to Tract(s) 3A, 3B relative to the interests of the Applicants identified in the attached petition.

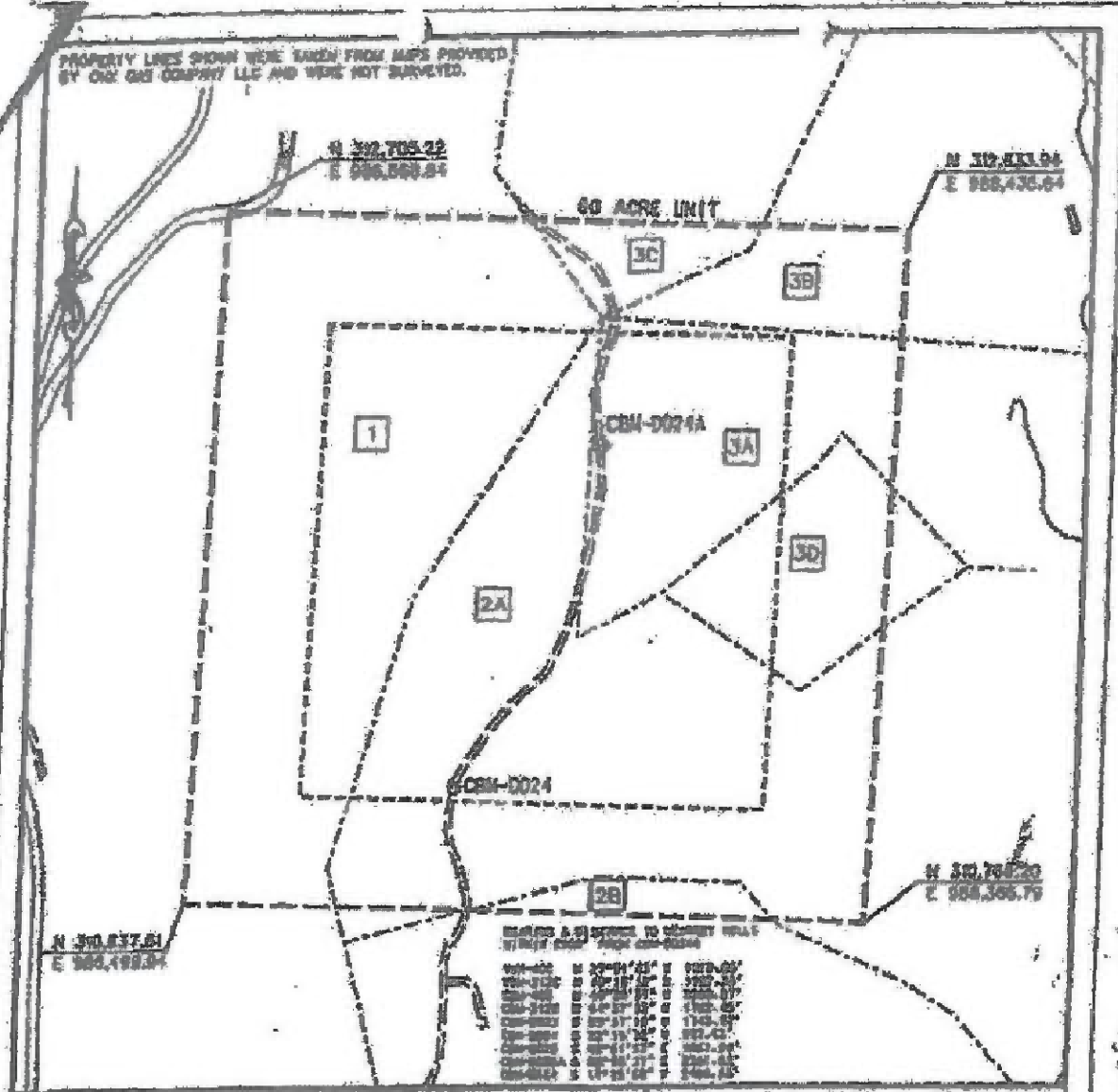
