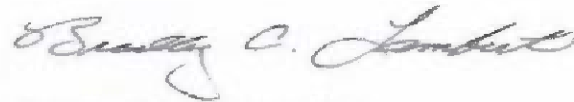
CONCLUSION:

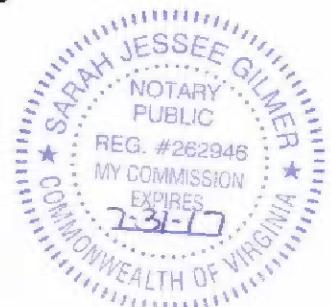

The foregoing Petition to the best of my knowledge, information, and belief is true and correct.

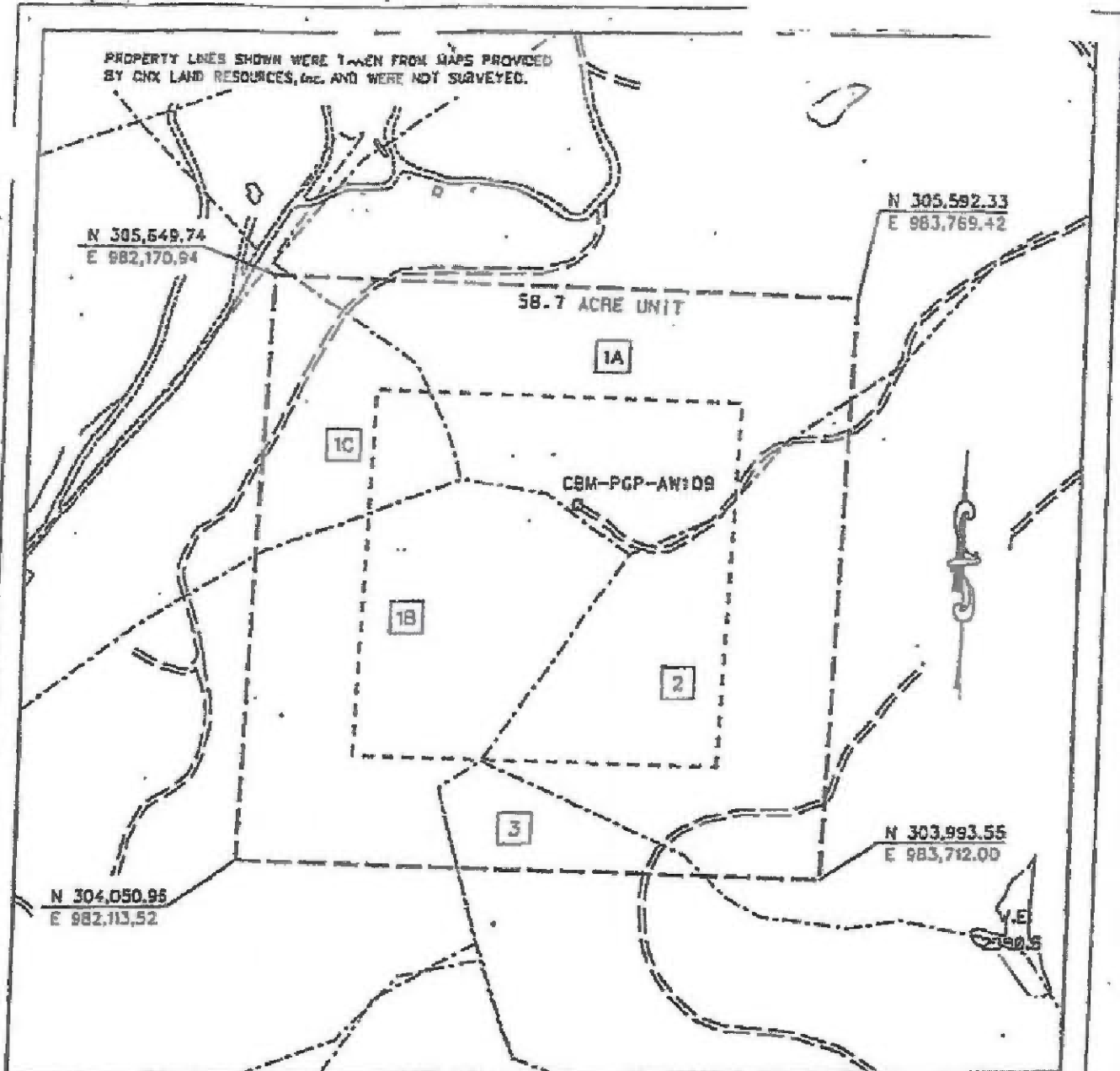
