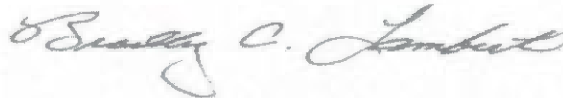
CONCLUSION:

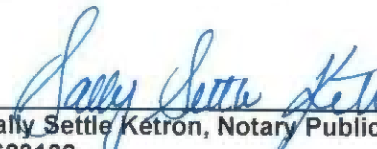

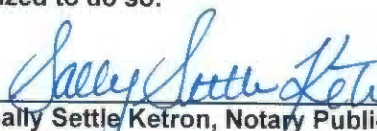

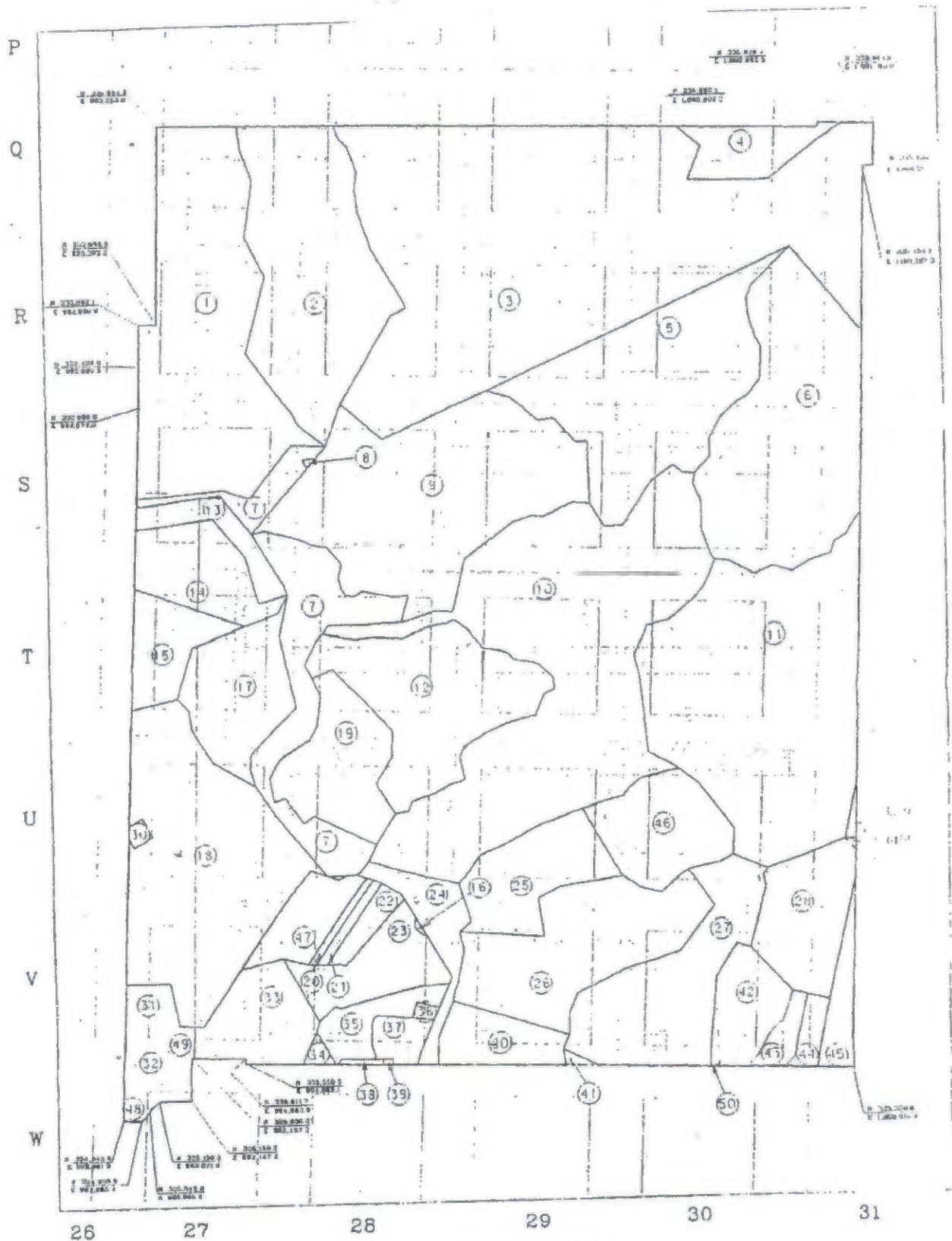
