Applicant has certified and represented to the Board that:

- a. Randal Lockhart, Ricky Strouth, and Christopher Price are the gas claimants in a portion of Tr. 1D and portion of Tr. 1E. As such Randal Lockhart, Ricky Strouth, and Christopher Price are entitled to 100% of the CBM royalties attributable to their gas claims that are now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- b. That CNX Gas Company LLC has previously given the notice(s) required by § 45.1-361.22:2.A to all conflicting coal claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- c. That when the Board granted Petitioner's Miscellaneous Petition in VGOB 04-0720-1310-01, it dismissed the coal claimant(s) Swords Creek Land Partnership as a Respondent to these proceedings. Accordingly, Swords Creek Land Partnership was not provided further notice under § 45.1-361.19 and 22 of the hearing set on this Petition.


CONCLUSION:



