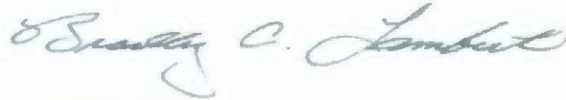
CONCLUSION:

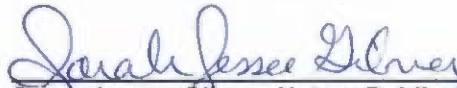

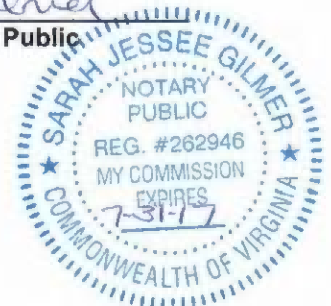

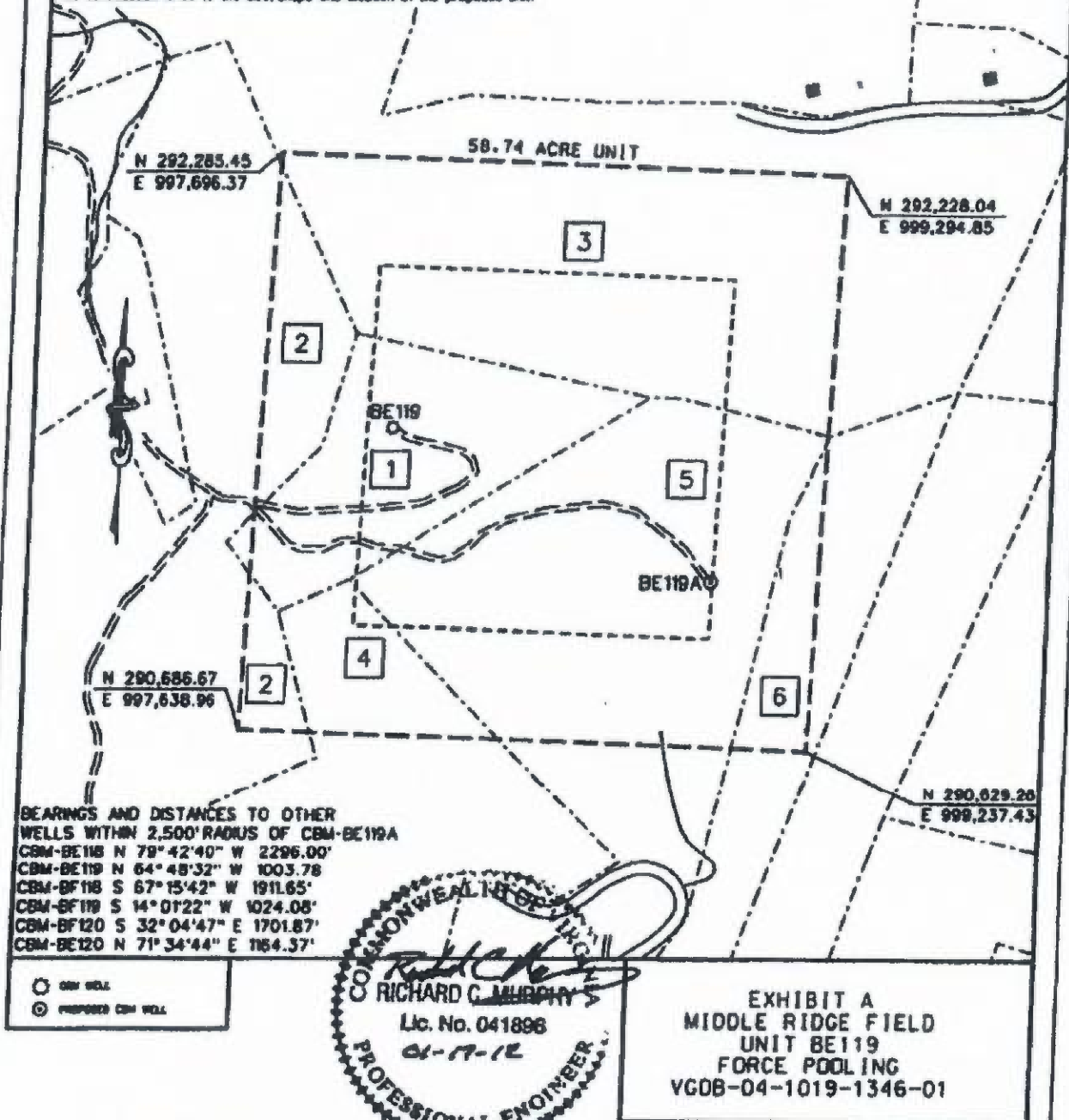
