**NOTICE:**

**FINDINGS:** Code of Virginia § 45.1-361.22 AND § 45.1-361.22:2

Applicant has certified and represented to the Board that:

- a. Michael Murphy, Tabitha Nichols, Michael Bostic, Burley Childress, Wendell Childress, Donna Puckett, and Colleen Stanley are the gas claimants in a portion of Tr. 2. As such Michael Murphy, Tabitha Nichols, Michael Bostic, Burley Childress, Wendell Childress, Donna Puckett, and Colleen Stanley are entitled to 100% of the CBM royalties attributable to their gas claims that are now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- b. That CNX Gas Company LLC has previously given the notice(s) required by § 45.1-361.22:2.A to all conflicting coal claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- c. That when the Board granted Petitioner's Miscellaneous Petition in VGOB 06-0418-1616-01, it dismissed the coal claimant(s) Levisa Coal Company as a Respondent to these proceedings. Accordingly, Levisa Coal Company was not provided further notice under § 45.1-361.19 and 22 of the hearing set on this Petition.





