The Unit Operator gave notice to the Applicants that the Board would consider its disbursement petition at the May 15, 2012 hearing and consider whether to:

- (1) Amend the Pooling Order to provide for the disbursement of funds on deposit in the Escrow Account attributable to Tract 1 identified in the attached miscellaneous petition.
- (2) Delete the requirement that the Unit Operator place future royalties attributable to Tract 1 relative to the interests of the Applicants identified in the attached miscellaneous petition.
- (3) CLOSE the escrow account under this docket number.

FINDINGS: *Code of Virginia* § 45.1-361.22

Applicant has certified and represented to the Board that:

1. The owner of the coal estate for Tract 1 is Garden Realty for the subject drilling unit.
2. The owner of the gas estate for Tract 1 are Fairview Limited Partnership, Carl C. Irvin, F. H. Combs Testamentary Trust, Martha Combs c/of Benjamin E. Edwards &

Co., John W. Pobst, Jr. Virginia Linwick, Richard Pobst, Catherine Pobst and Meredith Jennings for the subject drilling unit.

3. Disbursement is required based on court order, Case Number 486-08 adjudicating the ownership of coalbed methane gas. The order stated that Fairview Limited Partnership, Carl C. Irvin, F. H. Combs Testamentary Trust, Martha Combs c/of Benjamin E. Edwards & Co., John W. Pobst, Jr. Virginia Linwick, Richard Pobst, Catherine Pobst and Meredith Jennings were entitled to 100% of the royalties. The Order was entered December 7, 2011

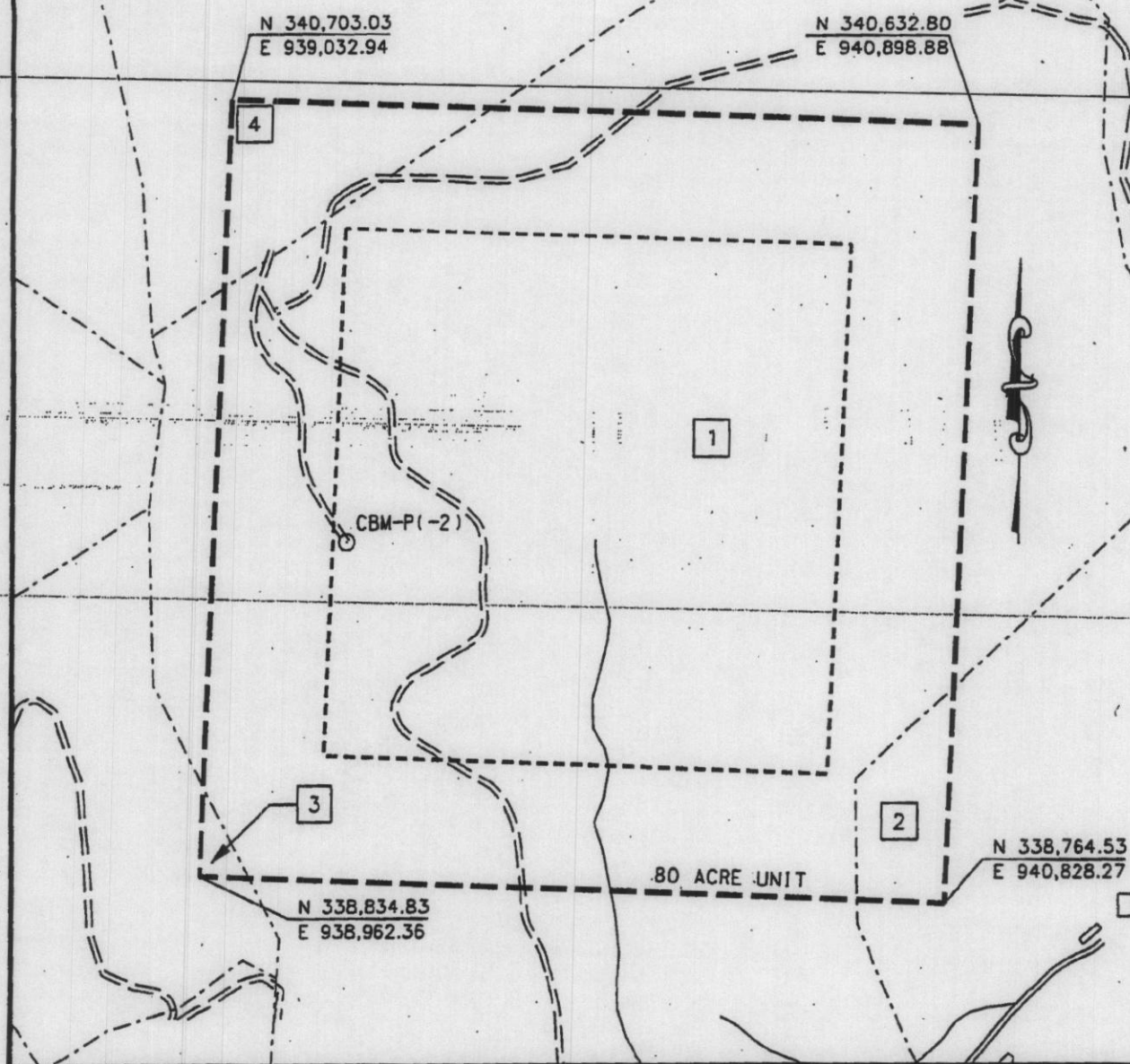
