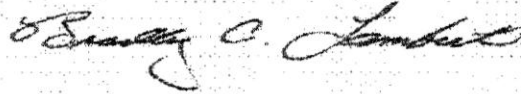
CONCLUSION:

APPEALS:

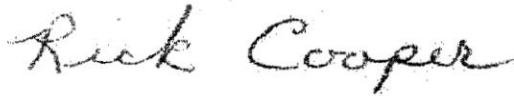

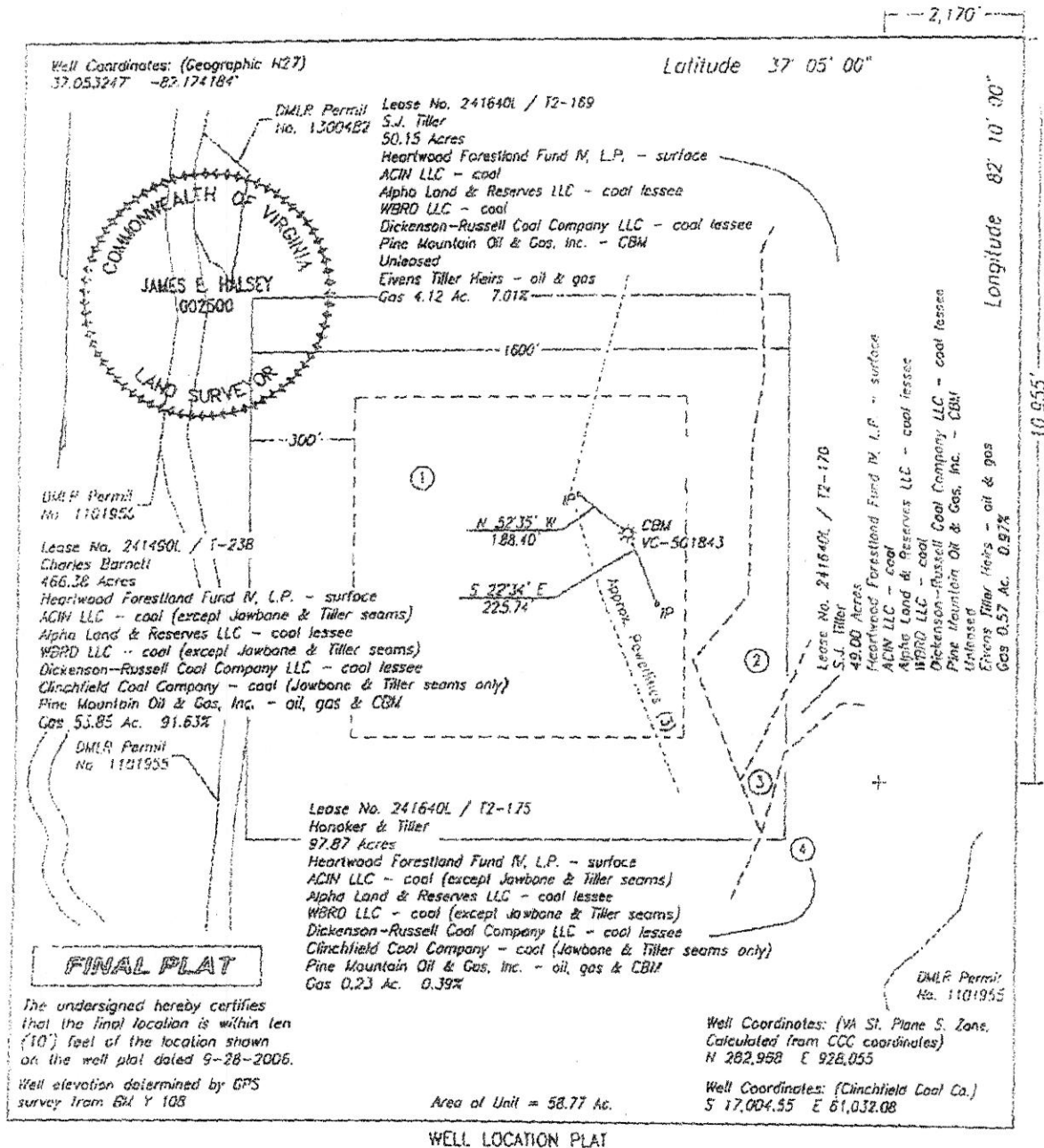
