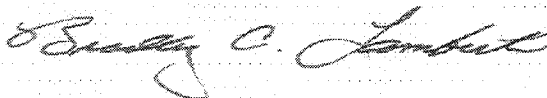
CONCLUSION:

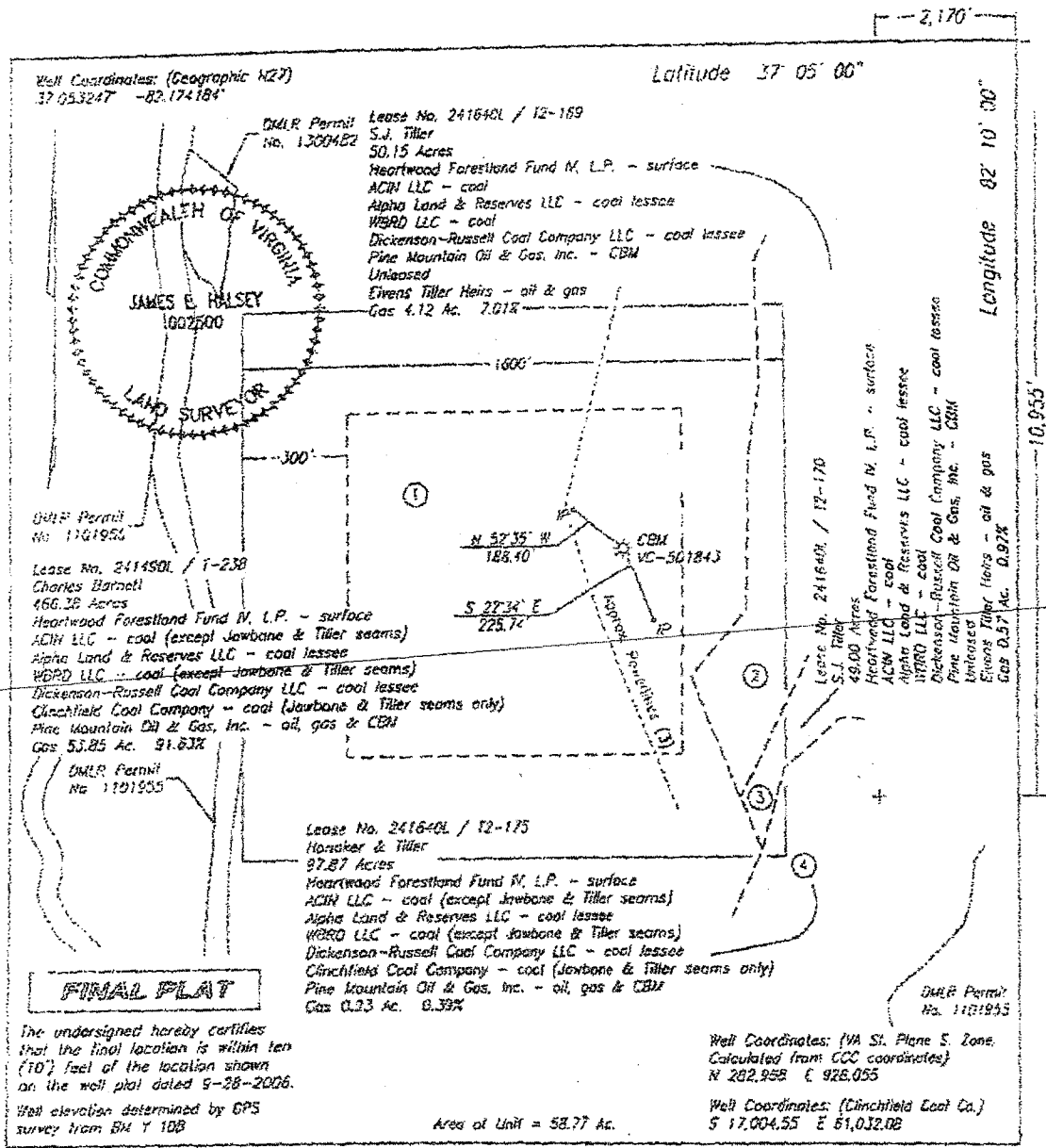
