As such Barbara Lester, Nancy Jackson, Jerry Hensley, Carole Jackson, and Coleen Christensen are entitled to 100% of the CBM royalties attributable to their gas claims that are now in escrow and as may be hereafter payable. - b. That CNX Gas Company LLC has previously given the notice(s) required by § 45.1-361.22:2.A to all conflicting coal claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- c. That when the Board granted Petitioner's Miscellaneous Petition in VGOB 07-0417-1915-01, it dismissed the coal claimant Commonwealth Coal Company. as a Respondent to these proceedings. Accordingly, Commonwealth Coal Company was not provided further notice under § 45.1-361.19 and 22 of the hearing set on this Petition.

CONCLUSION:


Therefore, the requested relief and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.





