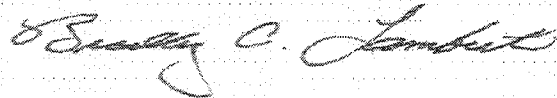
CONCLUSION:

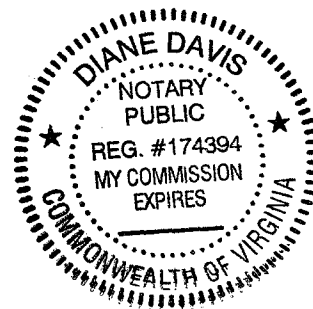

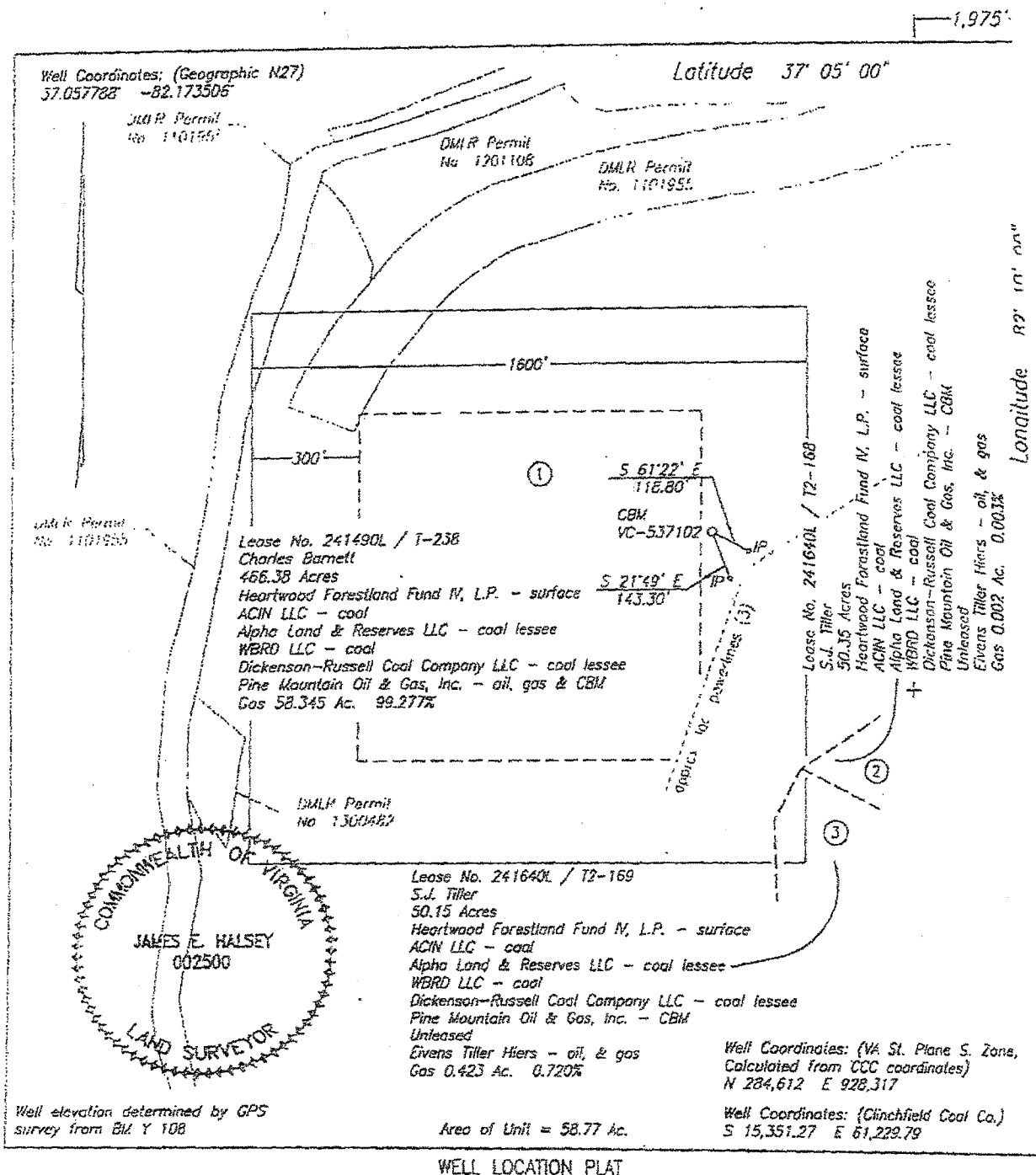
