NOTICE:

The Unit Operator gave notice to the Applicants that the Board would consider its disbursement petition at the February 21, 2012 hearing and consider whether to:

- (1) Amend the Pooling Order to provide for the disbursement of funds on deposit in the Escrow Account attributable to Tract 4 identified in the attached miscellaneous petition.
- (2) Delete the requirement that the Unit Operator place future royalties attributable to Tract 4 relative to the interests of the Applicants identified in the attached miscellaneous petition.
- (3) Close the escrow account under this docket number.

FINDINGS: Code of Virginia § 45.1-361.22

Applicant has certified and represented to the Board that:

1. The owner of the coal estate for Tract 4 is Garden Realty Corporation. for the subject drilling unit.

2. The owners of the gas estate for Tract 4 are Fairview Limited Partnership, Carl Irvin, F. H. Combs Testamentary Trust, Martha Combs, John W. Pobst, Jr., Virginia Lee Linwick, Richard Pobst, Catherine Pobst and Meredith Jennings for the subject drilling unit.
3. Fairview Limited Partnership, Carl Irvin, F. H. Combs Testamentary Trust, Martha Combs, John W. Pobst, Jr., Virginia Lee Linwick, Richard Pobst, Catherine Pobst and Meredith Jennings are entitled to 100% of the royalties according to the Order which was entered on December 7, 2011, Case No. 486-08, adjudicating the ownership of coalbed methane gas. This order allows the Applicant and Designated Operator to pay royalties directly to the prevailing plaintiffs identified on Exhibit EE annexed hereto and the annexed Exhibit A-1, further, specifies how said royalties are to be paid.

RELIEF GRANTED:

1. The Escrow Agent is ordered, to within ten (10) days of receipt of this executed order, disburse funds for the unit and applicants detailed in Table 1 attached.
2. The Escrow Agent is ordered to **CLOSE** the Escrow Account for the Subject Drilling unit based on the attached Revised Exhibit E which replaces all prior Exhibit E's recorded for the Subject Drilling Unit.

CONCLUSION:

Therefore, the requested relief and all terms and provisions set forth above be and hereby are granted and **IT IS SO ORDERED.**

APPEALS:

Appeals of this Order are governed by the provisions of the *Code of Virginia* § 45.1-361.9 which provides that any order or decision of the Board may be appealed to the appropriate circuit court and that whenever a coal owner, coal operator, gas owner, gas operator, or operator of a gas storage field certificated by the State Corporation Commission is a party in such action, the court shall hear such appeal de novo.
