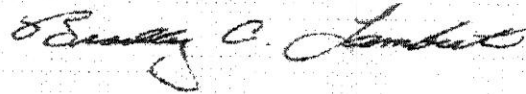
CONCLUSION:

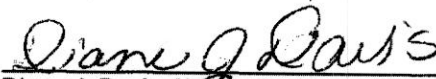

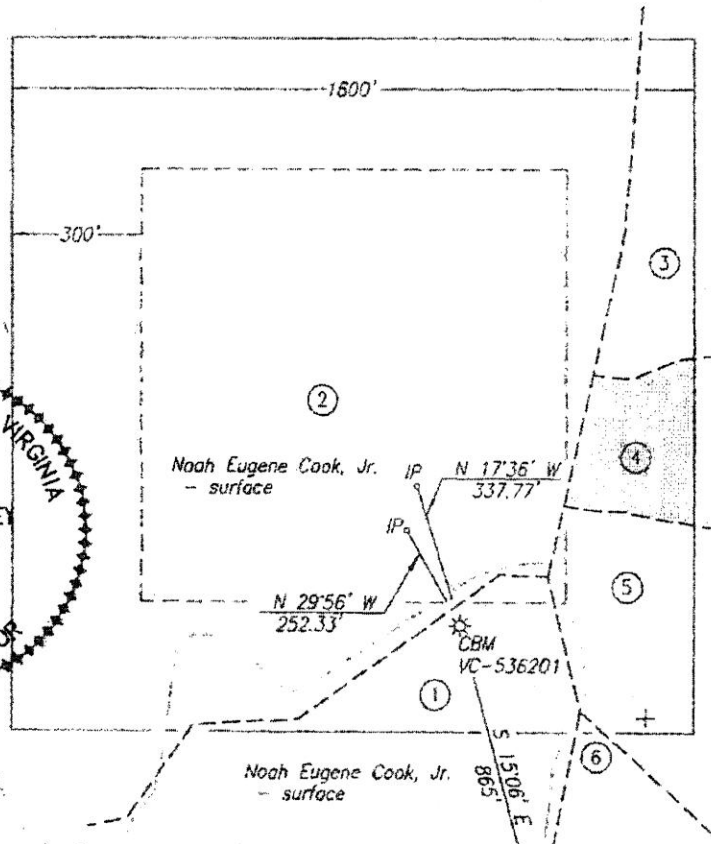
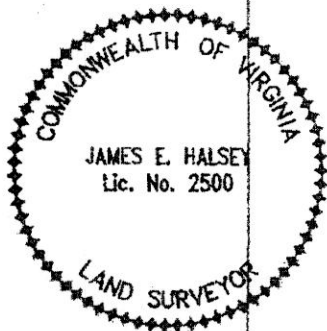
