Applicant has certified and represented to the Board that:

- a. Kevin Webb, Randy Webb, Terra Morris, Myra Compton, and Tyler Richardson are the gas claimants in a portion of Tr. 2A. As such Kevin Webb, Randy Webb, Terra Morris, Myra Compton, and Tyler Richardson are entitled to 100% of the CBM royalties attributable to their gas claims that are now in escrow and as may be hereafter payable. See Va. Code Ann. § 45.1-361.22:2.A.
- b. That CNX Gas Company LLC has previously given the notice(s) required by § 45.1-361.22:2.A to all conflicting coal claimants identified in the above referenced pooling Order and any supplemental Orders pertaining thereto.
- c. That when the Board granted Petitioner's Miscellaneous Petition in VGOB 12-0515-3063-01, it dismissed the coal claimant(s) Nancy Harman, Jonathan Harman, James Harman, III, Minnie Harman Estate, Pardee Royalty, Pocahontas Land Corporation, Southern Region Industrial Realty, Bettie St. Clair, White Wolfe Energy, and Buchanan Mining Co LLC (formerly Consol Buchanan Mining Co LLC) as a Respondent to these proceedings. 


