RELIEF SOUGHT: CHANGE UNIT OPERATOR NAME AND TRANSFER RIGHT TO OPERATE

REPORT OF THE BOARD

FINDINGS AND ORDERS

1. Hearing Date and Place: This Application came on for a final hearing before the Virginia Gas and Oil Board (hereafter "Board") at 9:00 a.m. on June 16, 2020, via a virtual call-in meeting due to COVID-19.
2. Appearances: The Applicant appeared by Jessica Greathouse & Timothy E. Scott, counsel, McKinnis and Scott, 135 West Main Street, Suite 200, Kingsport, TN 37660. Jerald Hess, Assistant Attorney General, was present to advise the Board.
3. Jurisdiction and Notice: Pursuant to Va. Code §§ 45.1-361.1, et seq., the Board finds that it has jurisdiction over the subject matter of the Application. Board Rule 4VAC25-160-120 specifically addresses petitions to change unit operators and the transfer of the right to operate. The Board caused notice of this Application and Hearing to be published as required by Va. Code § 45.1-361.19.B. and 4VAC25-160-120.C. Whereupon, the Board finds that the notice given satisfies all statutory requirements and the minimum standards of due process.
4. Relief requested: The Applicant requests that the Board enter an order (i) that changes the designated Unit Operator from Diversified Southern Production, LLC and Core Appalachia Operating, LLC to Diversified Production LLC; and (ii) that transfers the right to operate all units listed and Board items identified in Exhibit G to the Application from Diversified Southern Production, LLC and Core Appalachia Operating, LLC to Diversified Production LLC.
5. Relief granted: The relief requested by Applicant in this cause be and the same is hereby granted: (i) The Board's designated Unit Operator in each of the Drillings Units and Board Orders identified in Exhibit G to the Application is changed from Diversified Southern Production, LLC and Core Appalachia Operating, LLC to Diversified Production LLC; and (ii) Diversified Production LLC, is hereby authorized to operate the said Drilling Units and wells as provided and authorized in the Orders identified in Exhibit G, as supplemented and amended. In the event there are pending orders, yet to be entered, or pending petitions and/or applications, yet to be determined, all subsequent orders shall identify Diversified Production LLC, as the Board's Designated Operator.

6. Special Findings: The Board specifically and specially finds:

- 6.3. Exhibit F was received in evidence as the written approval of the existing, now former, designated operator.
- 6.4. Exhibit G was received in evidence. Exhibit G identifies all Board Orders requiring amendment, and they are hereby amended by this Order. Exhibit G identifies all drilling units subject to the said prior Orders of this Board.
7. Conclusion: Therefore, the requested relief and all terms and provisions set forth above be and hereby are granted and IT IS SO ORDERED.
8. Appeals: Appeals of this Order are governed by the provisions of Va. Code § 45.1-361.9 which provides that any order or decision of the Board may be appealed to the appropriate circuit court.
9. Effective date: This Order shall be effective as of the date of the hearing, stated above, when the Board approved the application.




