

**PUBLIC NOTICE OF INTENT TO ENTER
TO CONDUCT RECLAMATION ACTIVITIES**
(Abandoned Mine Land Program)

IN THE MATTER OF: **Bold Camp Phase I Project**

TO WHOM IT MAY CONCERN:

Virginia Energy, Mined Land Repurposing Program of the Commonwealth of Virginia, pursuant to the authority granted in the Virginia Coal Surface Mining Control and Reclamation Act of 1979 (Chapter 19, Article 4, Section 45.1-260 et seq.), with funding provided by the IIJA Grant, has determined and found that:

Land located off Right Fork Road in the Bold Camp area, SE of Pound in Wise County(ies), Virginia, has been adversely affected by past coal mining practices, to wit:

1. Property owners, both known and unknown, are hereby notified of the Department's intention to reclaim the area adversely affected by past coal mining practices. The purpose of this Notice is to provide notice to any landowners, heirs, assigns and devisees who may be affected by the proposed reclamation and who have not been identified and who have not granted written consent.
2. The public health, safety and property is endangered by: **Priority 1 Clogged Stream and Priority 1 Clogged Stream Lands.**
3. The proposed action consists of:
 - a) Dewater and excavate existing sediment pond(s); install new culverts/barrel; re-establish embankments (2 locations)
 - b) Restore or improve the channel/floodplain; clean out sediment; install outlet protection in various locations
 - c) Construct embankment to create wetland; excavate to widen floodplain at various pinch points; relocate green space due to floodplain widening
 - d) Reconstruct drive through channel at Musket Lane; elevate Hershey Road and installation of clear span bridge with the driveway access reconstruction
 - e) Possible stormwater structures in various locations
