

**PUBLIC NOTICE OF INTENT TO ENTER
TO CONDUCT RECLAMATION ACTIVITIES**

(Abandoned Mine Land Program)

IN THE MATTER OF: **Big Vein Road Portal**

TO WHOM IT MAY CONCERN:

The Virginia Department of Energy, of the Commonwealth of Virginia, pursuant to the authority granted in the Virginia Coal Surface Mining Control and Reclamation Act of 1979 (Chapter 19, Article 4, Section 45.1-260 et seq.) with funding provided by the **FY22** Consolidated Grant, has determined, and found that:

Land located on **located 1.3 miles northwest of the intersection of State Route 652 and Big Vein Road** in **Montgomery** County(ies), Virginia, has been adversely affected by past coal mining practices, to wit:

1. Property owners, both known and unknown, are hereby notified of Virginia Energy's intention to reclaim the area adversely affected by past coal mining practices. The purpose of this Notice is to provide notice to any landowners, heirs, assigns and devisees who may be affected by the proposed reclamation and who have not been identified and who have not granted written consent.
2. The public health, safety and property is endangered by: **mine openings, and the subsidence area.**
3. The proposed action consists of:
 - a) Closure of open mine portal
 - b) Repair and stabilization of subsidence area.
 - c) Establishing drainage control over the affected area
 - d) Regrade the disturbed areas
 - e) Revegetation of all disturbed areas.
